School Policy

Digital technologies have become integral to the lives of children and young people, both within Schools and outside School. These technologies are powerful tools, which open up new opportunities for everyone. These technologies can stimulate discussion, promote creativity and stimulate awareness of context to promote effective learning. Children and young people should have an entitlement to safe internet access at all times.

This Acceptable Use Policy is intended to ensure:

- that children and young people will be responsible users and stay safe while using the internet and other digital technologies for educational, personal and recreational use.
- that School systems and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk.

The School will try to ensure that girls will have good access to digital technologies to enhance their learning and will, in return, expect the girls to agree to be responsible users.





Acceptable Use Policy Agreement

I will act as I expect others to act toward me:

I recognise that the School has a responsibility to maintain the security and integrity of the technology it offers me, and to ensure the smooth running of the School:

• I will only use my own personal devices in School if I have	
permission. This includes:

If I do use my own devices in School, I will follow all the rules in this	
agreement, in the same way as if I was using School equipment.

• I will not use any programmes or software that might allow me	
to bypass the filtering and security systems.

When using the Internet for research or recreation, I recognise that:

• I should ensure that I have permission to use the original work of others in my own work	
 Where work is protected by copyright, I will not try to download copies (including music and videos) 	
• When I am using the internet to find information, I should take care to check that the information that I access is accurate	
• I understand that the work of others may not be truthful and may be a deliberate attempt to mislead me.	

I understand that I am responsible for my actions, both in and out of School:

٠	I understand that the School might take action against me if I am involved in incidents of unpleasant behaviour, that are covered in this agreement:	
	 when I am out of School and where they involve my membership of the School community (examples would be cyber-bullying, use of images or personal information). 	
٠	I understand that if I fail to comply with this Acceptable Use Policy Agreement, I may be subject to disciplinary action.	
•	Disciplinary action may include:
