### **School Policy**

Digital technologies have become integral to the lives of children and young people, both within Schools and outside School. These technologies are powerful tools, which open up new opportunities for everyone. These technologies can stimulate discussion, promote creativity and stimulate awareness of context to promote effective learning. Children and young people should have an entitlement to safe internet access at all times.

1. This Acceptable Use Policy is intended to ensure:

- that children and young people will be responsible users and stay safe while using the internet and other digital technologies for educational, personal and recreational use.
- that School systems and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk.

The School will try to ensure that pupils will have good access to digital technologies to enhance their learning and will, in return, expect the pupils to agree to be responsible users.



### 2. Acceptable Use Policy Agreement

<ul> <li>Where work is protected by copyright, I will not try to download copies (including music and videos)</li> </ul>	
<ul> <li>When I am using the internet to find information, I should take care to check that the information that I access is accurate</li> <li>I understand that the work of others may not be truthful and may be a deliberate attempt to mislead me.</li> </ul>	y

### 6. I understand that I am responsible for my actions, both in and out of School:
